



8th Annual stART on the Street Cultural Festival

Food Vendor Application

Sunday, September 19, 2010, 11am - 5pm (rain date September 26)

stART on the Street, Central New England's largest cultural street festival, is seeking food vendors for their 2010 Fall Festival! The expected attendance is 25,000 – 30,000 so don't miss out on this great opportunity!

General Information

- stART on the Street is an outdoor street festival taking place on a paved surface
- A 10'x10' tent and 8' table will be provided for each vendor
- The fee for food vendors is \$255 (space fee: \$200, City of Worcester temp. foodservice permit: \$55)
- stART on the Street organizers will obtain the necessary permits on your behalf
- You may supply more tables and/or equipment but all must fit in the 10 x 10 space, unless you make arrangements BEFORE the festival
- Participating vendors must currently be licensed to prepare and serve food in the City of Worcester
- Vendors will be accepted on a first-come-first-served basis; space assignment will be made by the food coordinator to ensure variety
- You must provide utensils and napkins; trash receptacles will be provided for customers
- Electricity is not available
- Propane OR a generator may be used, provided you obtain the necessary permit from the Worcester Fire Department
- Vendors are required to hold and serve food at appropriate safe temperatures. An inspector from the City of Worcester will be on hand inspecting all vendors during the event
- We suggest you provide only a few specialty items, rather than an extensive menu with numerous items for sale
- If your application lists an item that is already being provided by another vendor, you may be asked to substitute another item. Preference will be given to vendors in the order their applications are received. In other words: SEND IN YOUR APPLICATION ASAP!!!
- Vendors must display clear and concise menus with prices and a sign with your business name
- Vehicles will have limited access to the food court between 11am - 5pm during the festival; arrangements must be made in advance if you require deliveries to your space
- Vendors are responsible for removing any trash from the production of your menu items
- You must commit to both the September 19th festival date and the rain date of September 26th
- Vendor information will be listed on www.startonthestreet.org . Send your .jpg logo to sarah@startonthestreet.org to be added to the listing
- A package of information concerning the festival will be mailed the last week in August
- Space fees are non-refundable. No exceptions!
